Dear Inopak Customer;

This is to inform you of a product recall involving Cosmetic Products manufactured, packaged and distributed by Inopak LTD of Ringwood, NJ.

As part of Inopak’s on-going commitment to product quality we have determined through our quality processes there may be a potential for a limited number of containers of our hand soaps that are not GMP compliant.

While we have no reported customer issues or adverse events, in an abundance of caution, we are recalling those products manufactured at our Ringwood, NJ facility between January 1, 2016 and June 30, 2018.
